#### Scheme Fees for 2020-21

The majority of Scheme fees have been held at 2020-21 prices. A slight increase in the fee for Scheme 10 has been made in line with an increase in operating costs for this scheme. We would like to reiterate to our customers that we operate on a not-for profit basis, and as such will always provide our services at the lowest price we can offer to maintain operations.

Please remember that all invoices must be paid in <u>UK STERLING</u> (<u>GBP - £</u>) AND FREE OF ALL BANK CHARGES. We are experiencing more invoices being paid in a foreign currency resulting in outstanding balances being left on accounts. Please also ensure that if your laboratory is not subject to UK VAT, that a valid VAT number is recorded during the registration process. Registrations without this information will be charged UK VAT as standard. An administration fee will be payable if invoices have to be re-issued. Outstanding balances will result in suspension from all services until your account balance is cleared.

#### 2. Scheme Updates for 2021-22

#### Scheme 5A, 7 and 8 Sample Distribution Frequency

The frequency of sample distribution for Scheme 5A – HFE Typing, Scheme 7 – HLA\*B57:01 Typing for Drug Hypersensitivity and Scheme 8 – HLA Genotyping for Coeliac and Other HLA Diseases will continue to be distributed for assessment three times a year. The first distribution will contain three samples, the second distribution will contain four samples and the final distribution will contain three samples. This is to ensure EQA samples are representative of laboratory performance by sampling laboratory testing more regularly.

#### Scheme 3 – HLA Antibody Specificity Analysis

Following a survey asking Participants of Scheme 3 if they would like to able submit antibody results for assessment at HLA-DQA and HLA-DPA there will now be the option to select whether you would like to be assessed for antibody definition at HLA-DQA and / or HLA-DPA.

Participants are encouraged to submit antibody results at HLA-DQA and HLA-DPA. Please note these results will not be formally assessed in 2021-22. Instead, data will be collected and analysed to inform whether formal assessment in 2022-23 will be introduced.

#### Scheme 8 – HLA Genotyping for Coeliac and Other

#### **HLA Diseases**

New for 2020-21, participants may select to be assessed for the detection of HLA-B\*58:01 to support hypersensitivity testing to Allopurinol. After a trial period this may be moved to form part of Scheme 7 – HLA-B\*57:01 Typing for Drug Hypersensitivity.

#### **3. BREXIT**

We are continuing to adapt our working practices in line with

the new BREXIT regulations. The full ramifications of BREXIT are still being realised so while we are in this transition process we encourage you to report any problems you might have, particularly with sample delivery, so we can investigate and resolve any issues.

#### 4. The Participant's Portal

The UK NEQAS for H&I Participant Portal allows users to manage their EQA Scheme participation.

User guides are available for laboratory users and agents to guide you through the system and the functionality it offers. These guides appear on our website, and as links in the footer at the bottom of the Participant's Portal site.

Please register for the 2021-22 distribution year by logging on to the website and selecting **Registration**>Scheme Registration.

#### System Improvements for 2021-22

NEQAS continue to invest in the Portal to improve functionality. Many of the improvements will not be visible to Participants but some of the ones you will notice include:

- Making the navigation of performance tables easier
- Improving the format of Method table downloads

#### 4. Questions and Answers

Answers to some commonly asked questions:

## R: What do I do if I want to add additional Schemes to my registration mid-way through the year?

A: Primary Users can amend the lab registration at any point in the year by clicking the appropriate year in the Annual Registration section. This will open up the registration screens where you can view and amend what Schemes your lab will participate in. If you add an additional Scheme part way through the year you will only be billed for upcoming samples.

## R: My laboratory has two different analysers – can I register both for EQA?

A: Given that there is only one 'correct' result for each test, we recommend that laboratories do not have two separate registrations. We recommend that you subject one analyser to EQA and use daily IQC to assure that both are giving the same results. Alternatively, where the two analysers employ different processes, the EQA exercises can be alternated between the two, or half the samples tested on the first analyser and the other half on the second.

#### R: How do I amend the details of lab staff?

A: To make any changes to staff you need to be registered as a Primary User. Primary Users can simply click on the Staff option in the menu bar. This is bring up a list of all users for you lab and you can add, delete or change staff roles as required.

#### **Good News Stories**

NEQAS have a responsibility to ensure the quality of laboratory testing. We do this in many ways but one of which is our ability to report Manufacturers whose diagnostic kits are not performing in line with other technologies (and who fail to engage with direct communication from NEQAS) to the UK Medicines and Healthcare products Regulatory Agency for further investigation.



This has directly resulted in improvements to a kit used for testing for HLA alleles associated with Coeliac Disease. These improvements will assist in the interpretation of the results produced by the kit. This is especially important to assist laboratories who do not specialise in Histocompatibility and Immunogenetics but are still required to support testing for HLA in relation to defining susceptibility to Coeliac Disease.

NEQAS are also pleased to report that despite the many challenges of 2020 and 2021 they have been able to provide a complete EQA cycle with no reduction in samples or services!
