Scheme Fees for 2022-23

The majority of Scheme fees have been held at 2021-22 prices. A slight increase in the fees for Schemes 1B, 10 and 11 has been made in line with an increase in operating costs for these schemes. We would like to reiterate to our customers that we operate on a not-for profit basis and as such will always provide our services at the lowest price we can offer to maintain operations.

Please remember that all invoices must be paid in <u>UK STERLING (GBP - £) AND FREE OF ALL BANK CHARGES.</u> We are experiencing more invoices being paid in a foreign currency resulting in outstanding balances being left on accounts. Please also ensure that if your laboratory is not subject to UK VAT, that a valid VAT number is recorded during the registration process. Registrations without this information will be charged UK VAT as standard. An administration fee will be payable if invoices have to be re-issued. Outstanding balances will result in suspension from all services until your account balance is cleared.

Annual Participants' Meeting

NEQAS host a participant meeting annually which allows us to feedback on performance over the previous year, highlight any issues or interesting trends and to inform participants of any changes for the upcoming distribution year. It also allows us to have open discussions on relevant topics and gives our participants a forum to raise concerns or ideas for improvements. We invite guest speakers to cover relevant scientific content and strive to make the day as interactive as possible.

In response to the feedback from last years' virtual meeting we are doing things a little differently this year. One meeting will be held on the **24**th **May 2022** at a conference venue in Birmingham, UK. However, we acknowledge this means it is difficult for our participants based in the rest of the world to attend. As such, we will also be providing a second meeting for rest of world based labs using an online format on the **26**th **May 2022**. This meeting will be recorded and made available on our website.

Webinars

In 2021 we introduced our first series of Webinars which have focused on the interpretative Educational Scenarios sent in the 2021-22 distribution cycle. The Webinars were composed of a presentation summarising the scenario, the responses submitted and then an open Q&A session with a group of panellists. The panellists included NEQAS Steering Committee members, NEQAS staff and Clinical experts.

100% of delegates rated the first webinar as either beneficial or extremely beneficial to them with 97% stating they would be interested in attending more NEQAS Webinars!

2. Scheme Updates for 2022-23

Sample Distribution Frequency

The frequency of sample distribution for **Scheme 3** – HLA Antibody Specificity Analysis, **Scheme 6** – HLA Antibody Detection, **Scheme 4A1** – HLA Typing at 1st Field Resolution, **Scheme 4A1** – Interpretative HLA Genotype and **Scheme 4A2** – HLA Typing to 2nd and 3rd Field Resolution will be changing.

Samples for these schemes will now be distributed for assessment three times a year. The first distribution for Scheme 3, 4A1, 4A1i and 4A2 will contain three samples, the second distribution will contain four samples and the final distribution will contain three samples. Each of the three distributions for Scheme 6 will contain four samples. This is to ensure EQA samples are more representative of laboratory performance by testing regularly throughout the year. This should also decrease the burden of testing and reporting multiple samples at once.

3. EFI Standards: Core & Supplemental Techniques

<u>Core Techniques</u> are used individually or in combination to provide a final result

<u>Supplemental Techniques</u> are used only for rare cases in combination with core techniques to refine final result.

A reminder for EFI accredited laboratories that all 'core' laboratory techniques must be tested in accordance with minimum EPT sample numbers (e.g. 10 samples for HLA typing). Therefore, if you use multiple techniques for HLA typing, e.g. PCR-SSO & qPCR all EQA samples must be tested by both techniques. Only one result submission should be made to UK NEQAS, but relevant paperwork retained for inspections. Laboratories must document their approach for EQA testing using supplementary techniques, but the EFI EPT committee would recommend testing at least 2 EQA samples per year.

4. Participant Survey Responses

UK NEQAS for UK&I asked for your feedback on our services over the last two years. We would like to thank all those that generously gave their time to complete the survey. We use the responses to inform our service development. 87% of respondents rated our service as good or excellent and 90% of respondents rated our communication as good or excellent.

The survey highlighted a number of areas for improvement including:

- Accessibility of the Participants' Manual key information has been placed on our website where we hope you will find it easier to engage with https://ukneqashandi.org.uk/participant-area/.
- Ease of use of the Participants' Portal there are a number of
 user guides to assist you https://ukneqashandi.org.uk/portal-help/ we are also planning a series of instructional videos to
 clarify key functions which will be available on our website.
- Value for money although there was a significant improvement in the number of users rating us as good/excellent for value for money this is an area we would like to improve on.
 We would like to reiterate that we operate on a not for profit basis and any savings are always passed on to our participants.
- Awareness of our Steering Committee many of you commented you were unaware of the role of our Steering Committee. We hope you will see them more during our Webinar series and there is also information on our website https://ukneqashandi.org.uk/steering-committee/.
- Sample delivery delays a number of labs have experienced delays in getting samples after the changes imposed after Brexit. We have invested a lot of time trying to remedy any issues by working with our courier and the relevant customs departments. Delays can affect the quality of our isolated cells, we are currently performing a study to maximise the stability of our prepared lymphocytes to make them more resilient.

Participant Survey Responses Q&A

Q: Can you change Scheme 3 data entry to allow the download of data files directly from analysis software?

A: Scheme 3 requires an overall interpretation of the HLA antibodies present in a sample. We do not specify what method you should test by. The Steering Committee does not feel that taking an approach whereby labs could download results from programmes such as Fusion or MatchIT fits with the ethos of the Scheme as labs may test by multiple techniques to reach a final result.

Q: Can you provide more sample volume for Scheme 11?

A: Following this request NEQAS will be increasing the volume of serum received for each serum sample in Scheme 11 from 1ml to 1.5ml.



Q: Can you provide guidance on what testing strategy and methodology we should utilise for Scheme 11?

A: Testing strategy should be based on the clinical requirements of the services your lab supports. You need to have a level of detection available by whatever platform(s) you deem meets your throughput, budget and clinical requirements. NEQAS assess the interpreted result rather than specifically asking for the output from one type of test. We would also remind participants that there is methodology information available for each Scheme within the Portal which would allow you to assess various testing strategies and results submitted.

Portal Functionality - Did you know!?



Did you know you can print a summary of the results you entered and who entered/submitted them for all samples in a distribution:

- Select Results from the main menu and Pending Results or All Results.
- . Click the drop down arrow at the end of the row and select "Summary"



This will take you to a summary of entered results which you can view or download as a PDF. The report can then be saved to your computer or printed.
